Article 1:

Article 3:

Both organizations agree to the following general forms of co-operation, subject to available resources:


1. Free institutional membership will be given to the college.

6. Encourage students of either institute to attend lecturer in the other institute during lecturer session, seminars and conferences.
7. Provide academic interaction by delivering special lectures at institute on topics of modern research.
8. To provide facility of digital classroom, training and placement, digital library etc. at institute.
9. To organize national and international level career guidance and counselling camp.
10. To facilitate the training for teacher, students.

Article 4:

Confidentiality: Each party shall maintain complete confidentiality of any information of the other, disclosed during the term of this MOU.

Article 5:


